**RESOLUTION ADOPTING A REVISED AGENCY MEETING CALENDAR FOR THE
REMAINDER OF CALENDAR YEAR 2015**

WHEREAS, pursuant to Chapter 23, Laws of 1975, known as THE OPEN PUBLIC MEETING ACT, all meetings of any public body organized under the law of the State and whose members are collectively empowered as a voting body to spend public funds and conduct discussions relating to the public business, are required to be publicly announced and scheduled with adequate posting and advanced newspaper notice as to time, date, location and to the extent known, the purpose of the agenda of each such meeting; and


